Emergency Powers (Coronavirus) (People, Places and Activities) Regulations 2020

PEOPLE, PLACES AND ACTIVITIES (CORONAVIRUS) DIRECTIONS 2020

Laid before Tynwald:

Coming into Operation: in accordance with direction 1

The Department of Health and Social Care makes the following Directions under regulation 4, 6, 7 and 8 of the Emergency Powers (Coronavirus) (People, Places and Activities) Regulations 2020.

In accordance with regulation 9 of those Regulations, the Department has consulted with the Director of Public Health and the Council of Ministers before issuing these Directions.

PART 1

INTRODUCTORY

1 Citation and Commencement

- (1) These Directions are the People, Places and Activities (Coronavirus) Directions 2020.
- (2) These Directions come into operation as soon as they are made¹.

2 Interpretation

In these Directions —

“**guidance**” means guidance issued and published by the Department for Enterprise, Department of Education, Sport and Culture or the Registrar General after consulting the Director of Public Health; and

“**responsible person**” means —

- (a) in the case of residential premises, the person who is responsible for the premises including the owner and occupier; and

- (b) in the case of all other premises, the person who is responsible for the premises, for carrying on a business from the premises including, the owner, manager, any other person who is responsible for the premises or business and any other person involved in managing entry to or the location of persons inside the premises or business.

PART 2

PROHIBITION ON MOVEMENT

There are currently no prohibitions on movement for a person who is asymptomatic.]

PART 3

PROHIBITION ON DANGEROUS ACTIVITIES

PART 4

PROHIBITION ON EVENTS AND GATHERINGS

3 Application

The directions in this Part apply to —

- (a) an attendee at a gathering in a public space;
- (b) an attendee at an event in a private space; and
- (c) where applicable under this Part, the responsible person for a private place.

4 Interpretation of Part 4

In this Part —

"**gathering**" means any meeting or assembly of 2 or more persons;

"**private space**" means a space other than a public space; and

"**public space**" includes —

- (a) any land or building or premises where the public is routinely allowed to enter without the need for the prior permission (such as parks and beaches) whether on payment or otherwise; and

- (b) any vehicle used in the provision of public transport by the Department of Infrastructure.

5 Prohibition on gatherings in public spaces

A gathering in a public space is prohibited unless it is an “exempted gathering”.

6 Exempted gatherings

- (1) An “exempted gathering” is a gathering in a public space referred to in paragraph (2).
- (2) Each of the following is an “exempted gathering” —
 - (a) a gathering of students and staff at a school or college in accordance with the Emergency Powers (Coronavirus) (Educational Institutions) Regulations 2020²;
 - (b) a gathering —
 - (i) at court for the purposes of a hearing or trial;
 - (ii) at premises from which the person is produced at court (via live link, in accordance with the Emergency Powers (Coronavirus) (Courts etc) Regulations 2020³); or
 - (iii) at premises and for the purposes of taking a juvenile to the premises from which the juvenile is so produced;
 - (c) a gathering to discharge the duties or functions of an attendee’s employment at —
 - (i) premises which may open under and in accordance with direction 10; or
 - (ii) a private dwelling;
 - (d) a gathering to provide or receive a public service including medical or other emergency assistance;
 - (e) a gathering by way of attendance at a sitting of, or proceedings in, Tynwald, its Branches and committees or at Tynwald hearings;
 - (f) a gathering to provide, or participate in the provision of, an emergency or necessary voluntary service;
 - (g) a gathering to address the medical needs of the person or a member of his or her household;
 - (h) a gathering to access public transport;
 - (i) a gathering by way of the use of public transport;
 - (j) a gathering to facilitate or complete a move to a new residence (freehold or leasehold);

- (k) a gathering at a funeral;
- (l) a gathering by no more than 10 people (excluding the person officiating and one other person required to be at the premises before and after the ceremony under the “Guidance issued by the Clerk of the Rolls”⁴) at a marriage or civil partnership ceremony and accompanying celebrations;
- (m) a gathering where all the attendees are members of the same household is also an exempted gathering regardless of the number of such members; and
- (n) a gathering not falling in (a) to (m) at which there are no more than 10 attendees.

7 Prohibitions on events: private spaces

An event in a private space is prohibited unless it is an “exempted event”.

8 Exempted events

- (1) Each of the following is an “exempted event” —
 - (a) an event at which the responsible person allows no more than 10 persons at any one time to enter or congregate in the outdoor or open air areas of premises (such as the garden);
 - (b) an event at which the responsible person allows no more than 2 persons from any one household at any one time, to enter —
 - (i) the person’s vehicle; or
 - (ii) any building forming part of premises;
 - (c) an event consisting of the attendance at school or college by both students and staff in accordance with the Emergency Powers (Coronavirus) (Educational Institutions) Regulations 2020⁵;
 - (d) an event by way of the attendance —
 - (i) at court for the purposes of a hearing or trial;
 - (ii) to attend premises from which the person is produced at court (via live link, in accordance with the Emergency Powers (Coronavirus) (Courts etc) Regulations 2020⁶); or
 - (iii) at premises and for the purposes of taking a juvenile to the premises from which the juvenile is so produced;
 - (e) an event consisting of attendance at premises which may open under and in accordance with direction 10;

- (f) an event in order to provide, or participate in the provision of, an emergency or necessary voluntary service ;
- (g) an event which takes place in order to care for a child or an adult who would otherwise suffer avoidable harm;
- (h) an event which takes place in order to care for a child from another household; and
- (i) an event which takes place in the operation of hotels, hostels or boarding houses.

PART 5

PROHIBITION ON OPENING PREMISES AND BUSINESSES

9 Application of this Part

This Part applies to all premises and businesses in the Island.

10 Prohibition on opening and entering premises and businesses

- (1) A responsible person may open any premises or business unless the premises or businesses are specified in –
 - (a) Schedule 1, in which case the business or premises may open –
 - (i) to the limited extent;
 - (ii) for a purpose; or
 - (iii) subject to any conditions, specified in that Schedule ; or
 - (b) Schedule 2, in which case they must remain closed.

This direction is subject to paragraphs (3) and (4).

- (2) Despite paragraph (1), where –
 - (a) the Chief Minister announces that a business or premises to which paragraph (3) applies, is to be permitted to reopen from a specified date in the future, either generally or for a particular purpose and with or without conditions or restrictions; and
 - (b) details of the announcement are published on www.gov.im for the purpose of this paragraph,the responsible person may reopen the business or premises for the purposes specified and to the extent provided for in paragraph (3).
- (3) This paragraph applies to –
 - (a) a business or premises specified in Schedule 1, in which case the business or premises may open only to the extent necessary to allow preparations to be made in readiness for the business to

- open for a purpose or to an extent over and above that provided for in Schedule 1; or
- (b) a business or premises specified in Schedule 2, in which case the business or premises may only open to the extent necessary to allow preparations to be made in readiness for the business to reopen.
- (4) A responsible person in relation to any premises or business which is open under paragraph (1) or (2) must ensure that such measures as are reasonably practicable to reduce the risk of a person being infected with Coronavirus as a result of being present at the premises or business are put in place, including –
- (a) ensuring that the premises or business are regularly and frequently cleaned;
 - (b) ensuring that facilities are provided for enabling persons at the premises to clean or otherwise sanitise their hands frequently; and
 - (c) complying with any guidance issued and published for the purpose of this paragraph by the Department for Enterprise.
- (5) A person may enter premises or a business which is permitted to open under this direction provided that in doing so the person complies with any guidance referred to in paragraph (4)(c) and any conditions to which the premises or business are subject under Schedule 1.

These Directions are made by the Department of Health and Social Care.
