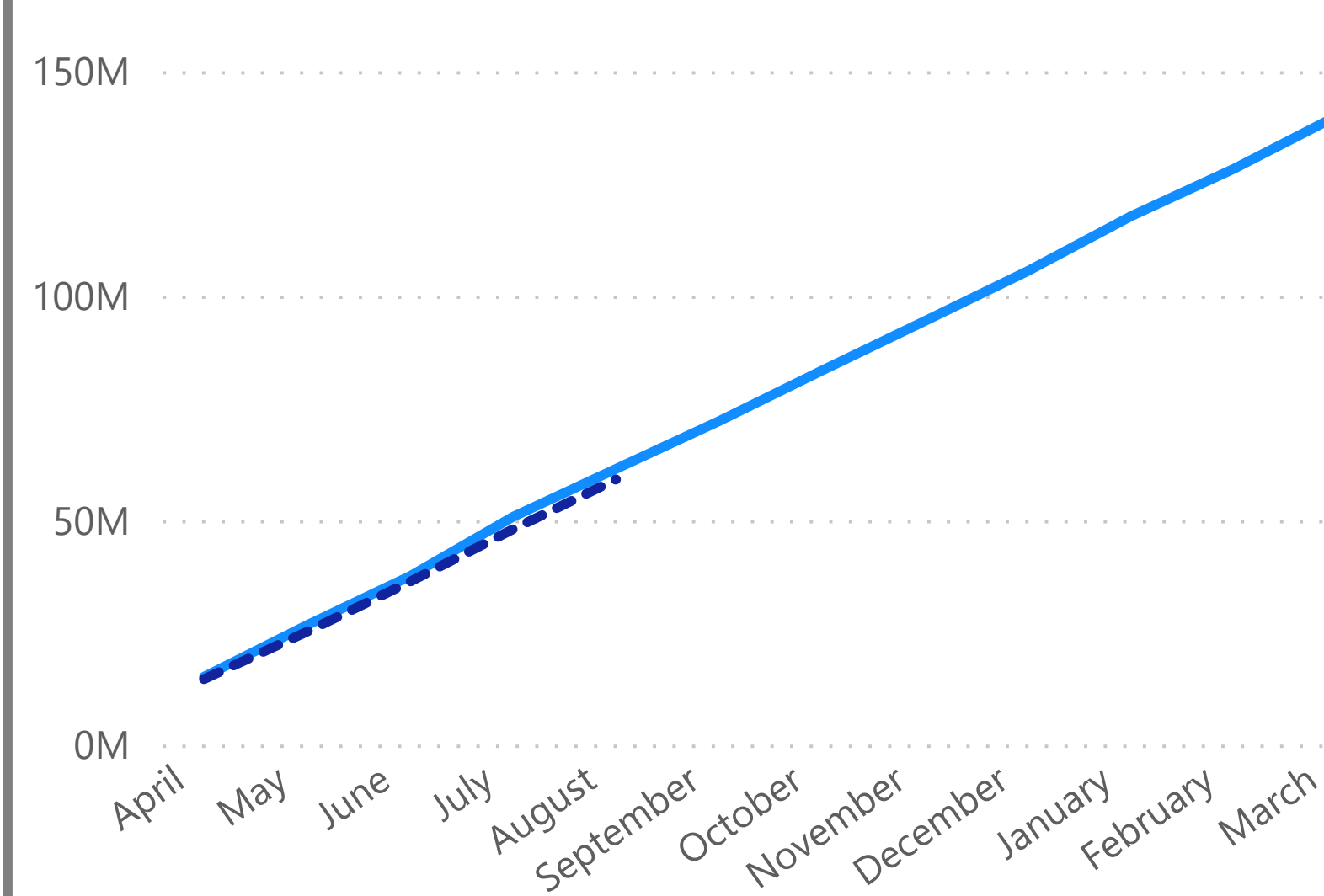

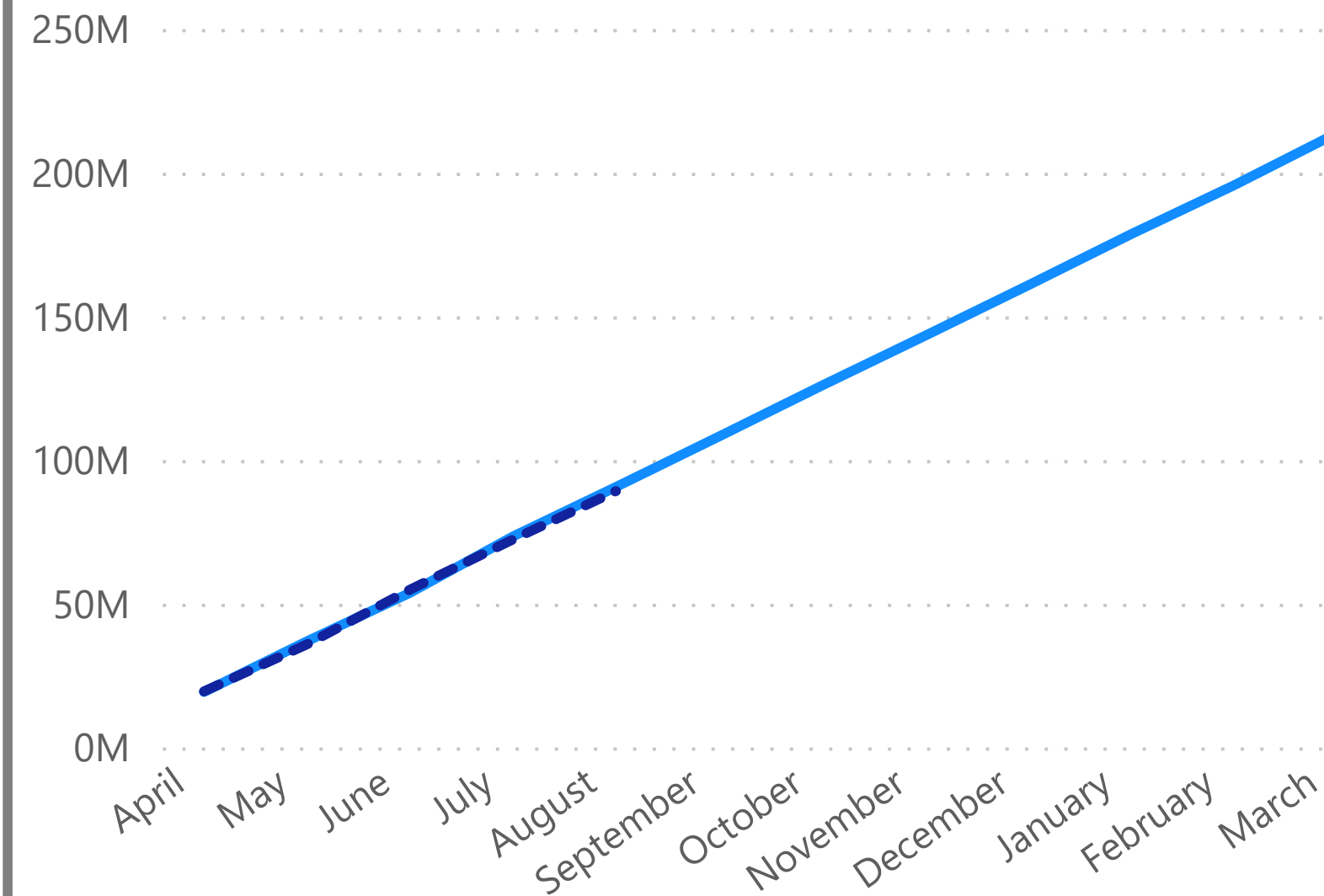

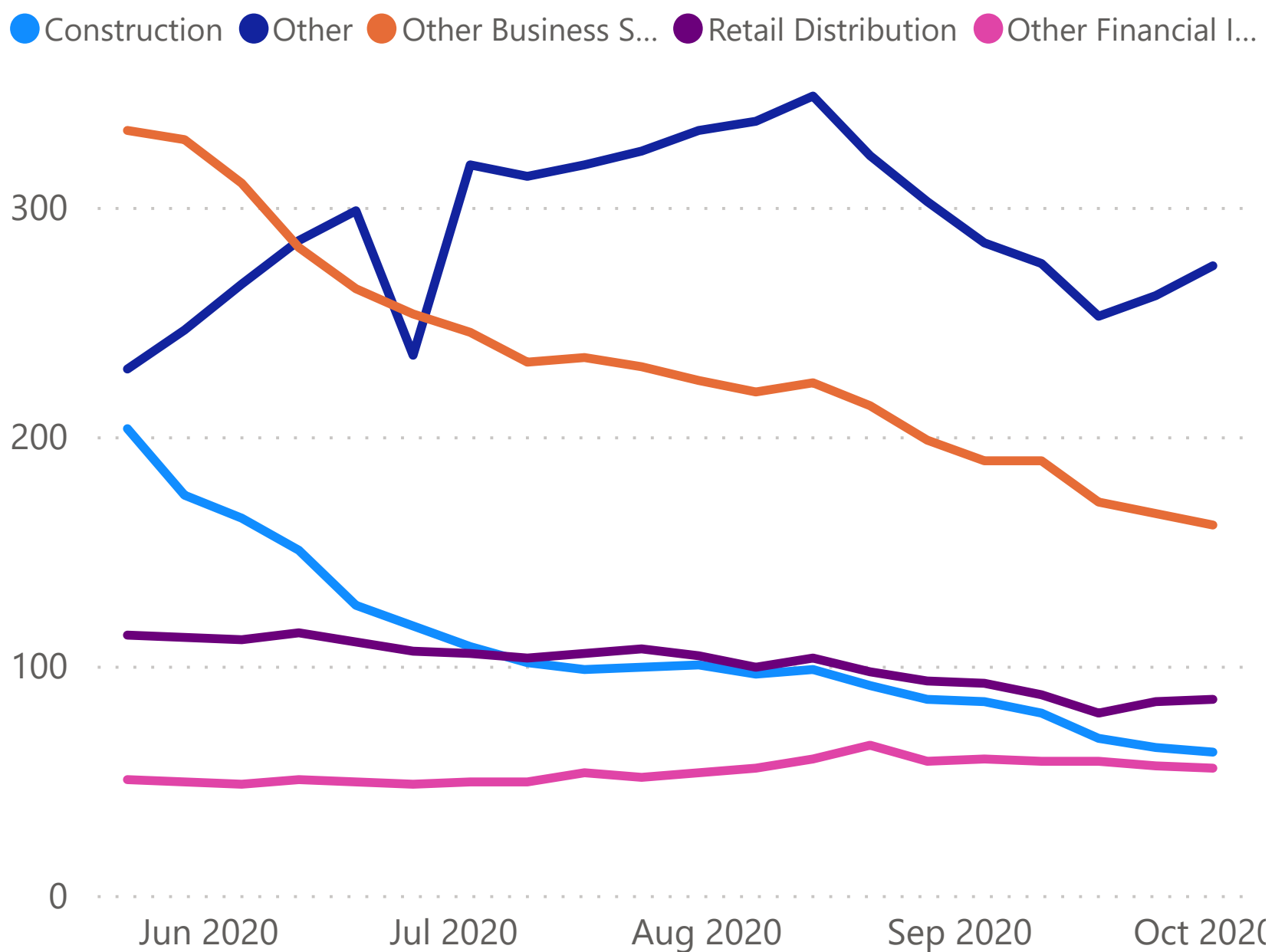

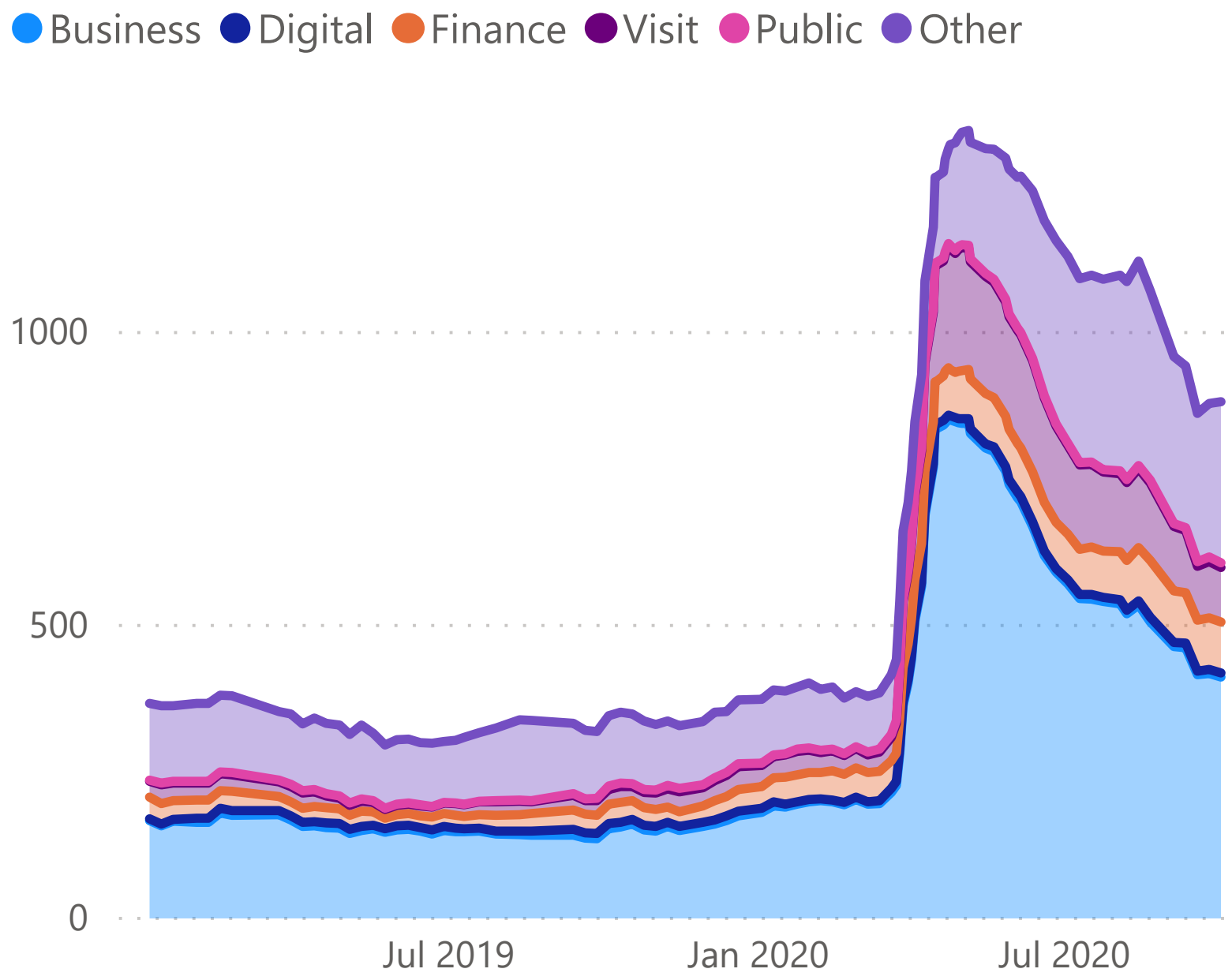

Top Five Occupations

No Previous Occupation is mainly returning students (40) and those transferring from other benefits (45). 46 individuals had neither a previous known occupation or known economic sector.

37/75 "Other Professions" are within Other Business Services, similarly 33/82 Other Admin sits within Other Business Services and is likely to be those who were temping with agencies.

Unemployment by Sector

Construction, Retail and Other Business Services make up 80% of Business Agency unemployment, of which Other Business is the largest.

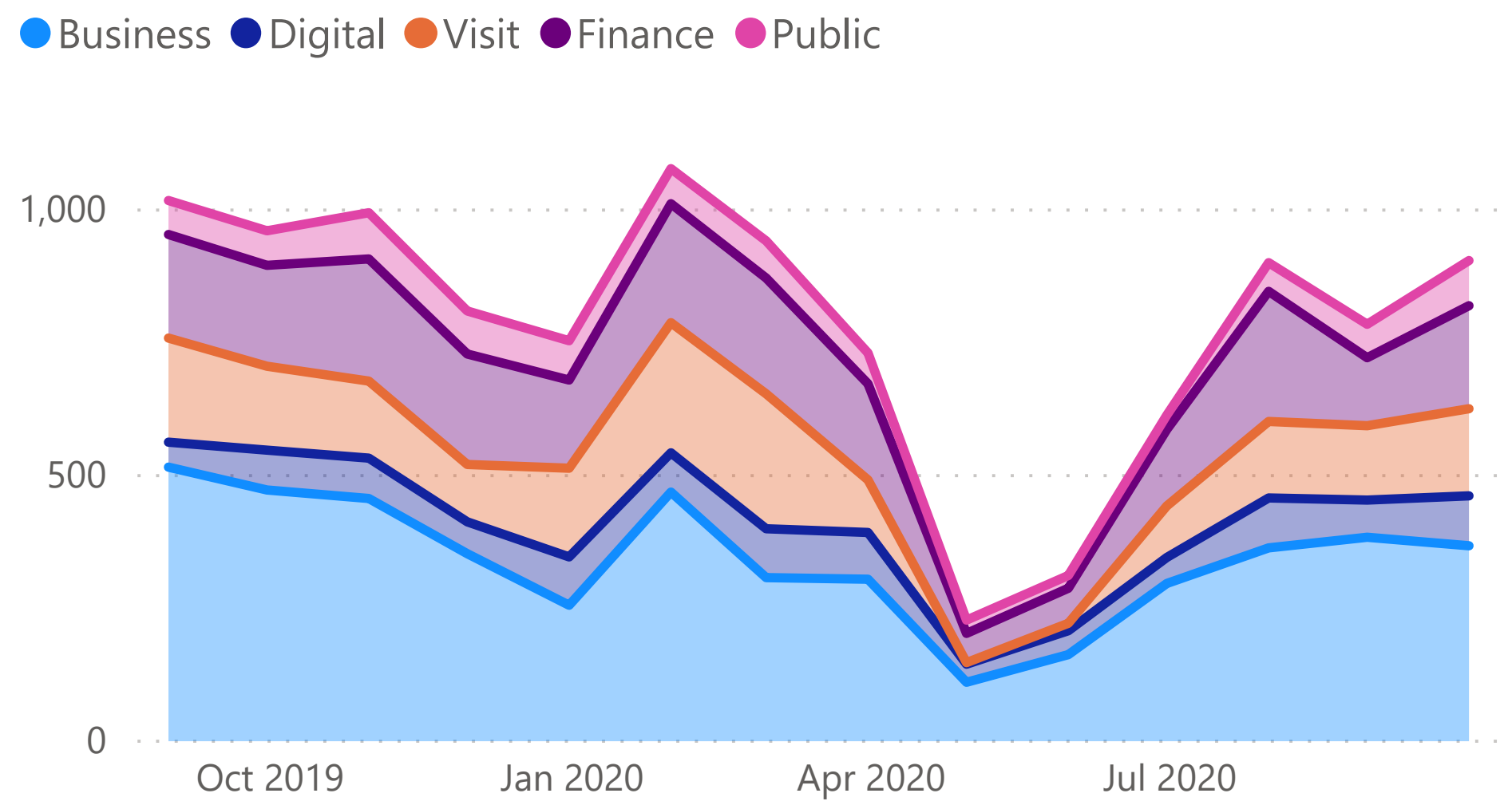
Other Professions (37), Other Admin/Clerical (33) and Cleaning (43) are the largest areas of Other Business Services.

Just under half of Construction is unskilled manual workers, with the other half across a wide range of trades.

Other is the same as Not Known in the Top Five Occupations above.

Most of those involved in Finance were in administrative/clerical roles.

Job Vacancies by Agency



Business - 368

Business Agency vacancies are driven by Construction (77), retail (79) and healthcare in the private sector (85). There were also a range of vacancies across education, engineering/manufacturing and cleaning.

Digital - 94

Vacancies within Digital are across a wide range of disciplines from developers, engineers, analysts and designers/publishers.

Finance - 194

Finance vacancies are focused on administrative vacancies (45), Qualified Accountants (31), Compliance roles (21), Lawyers (20) and managerial posts (20).

Visit - 164

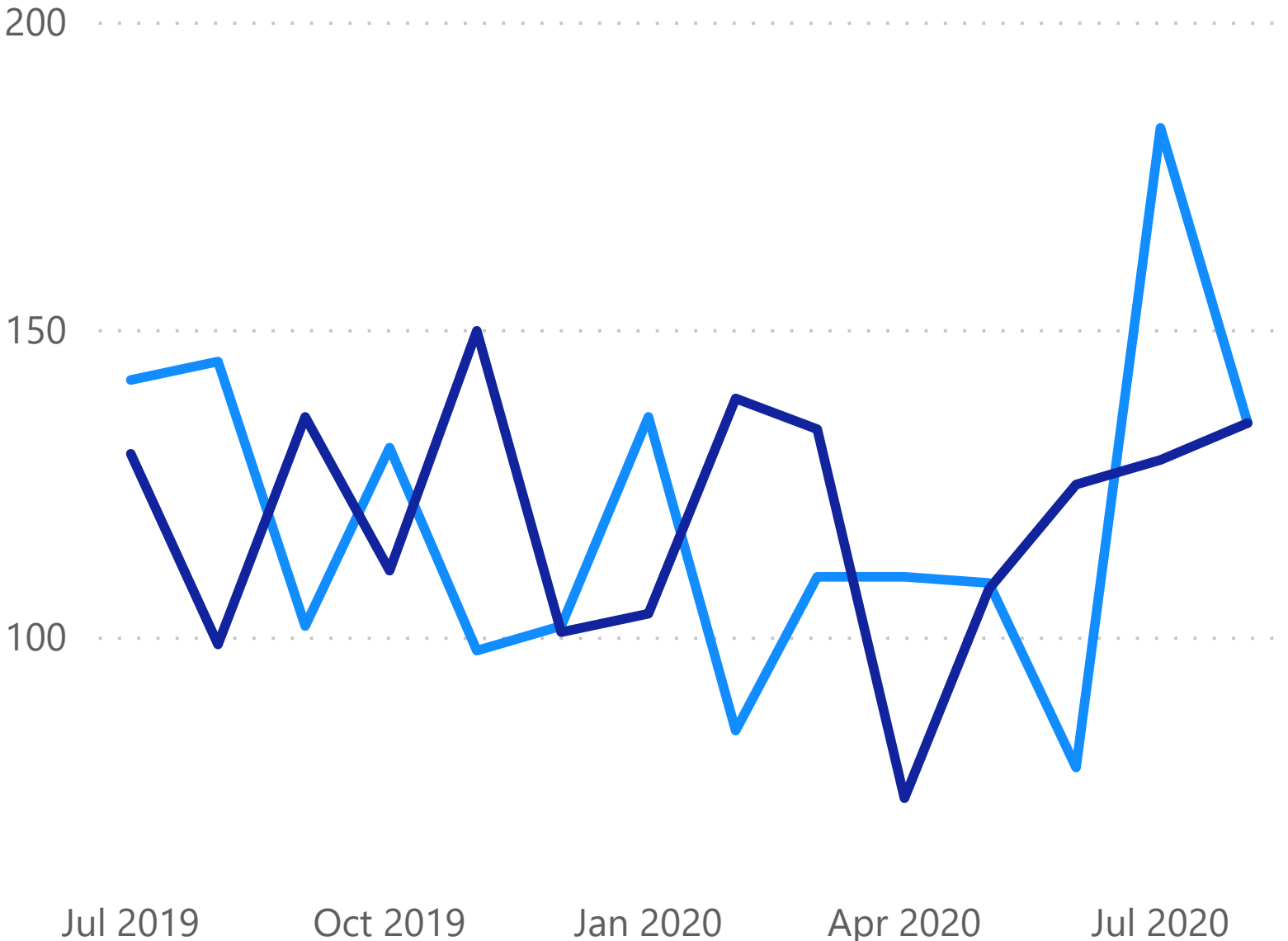
Vacancies here are focussed on front of house staff (58), and chefs (34), alongside kitchen assistants (45), which whilst not at record levels, are above average for the sector over the past 18 months. Vacancies in the tourism side still remain subdued as expected.

Public - 85

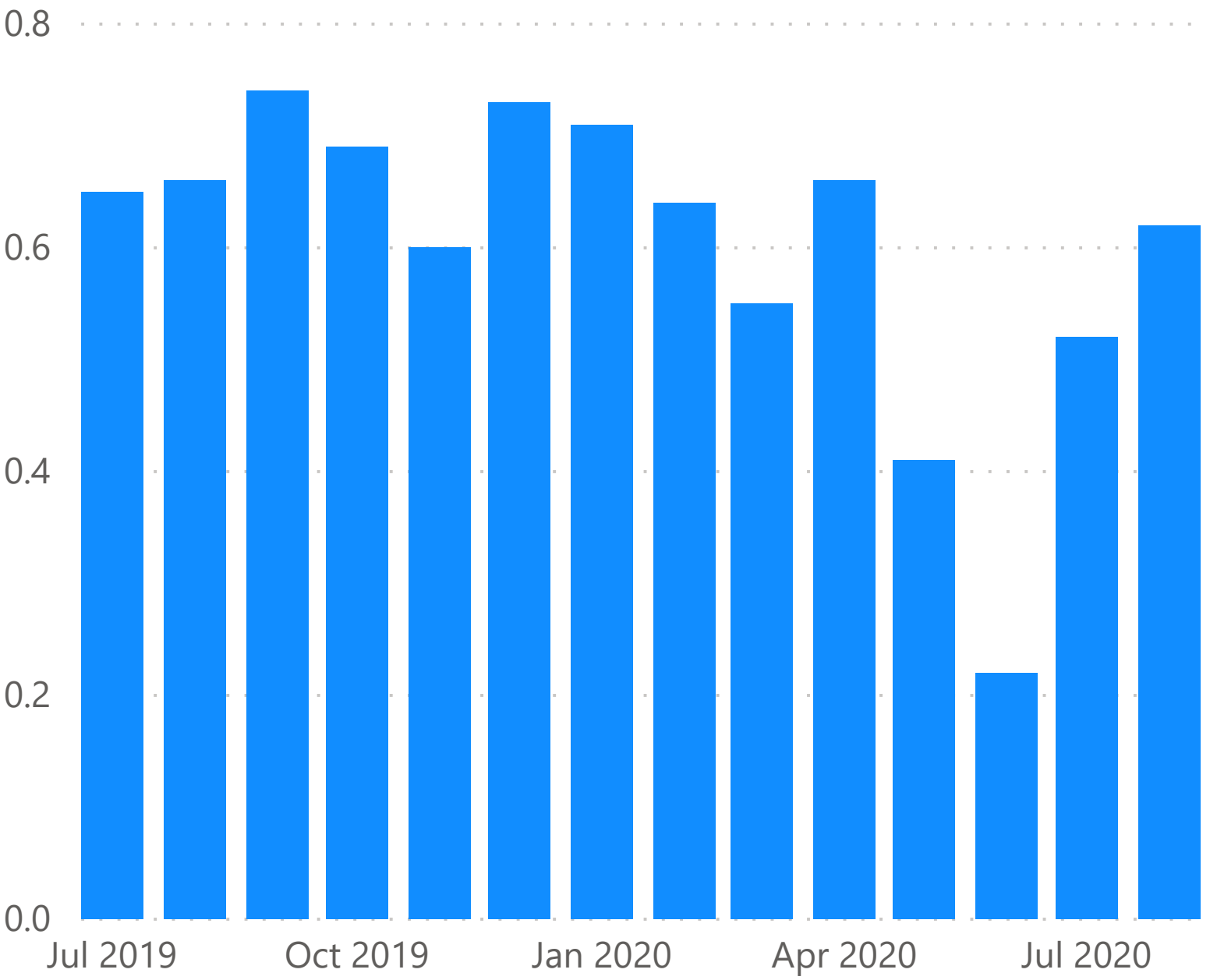
Healthcare roles (53) and Education (12) account for the majority of vacancies within the public sector.

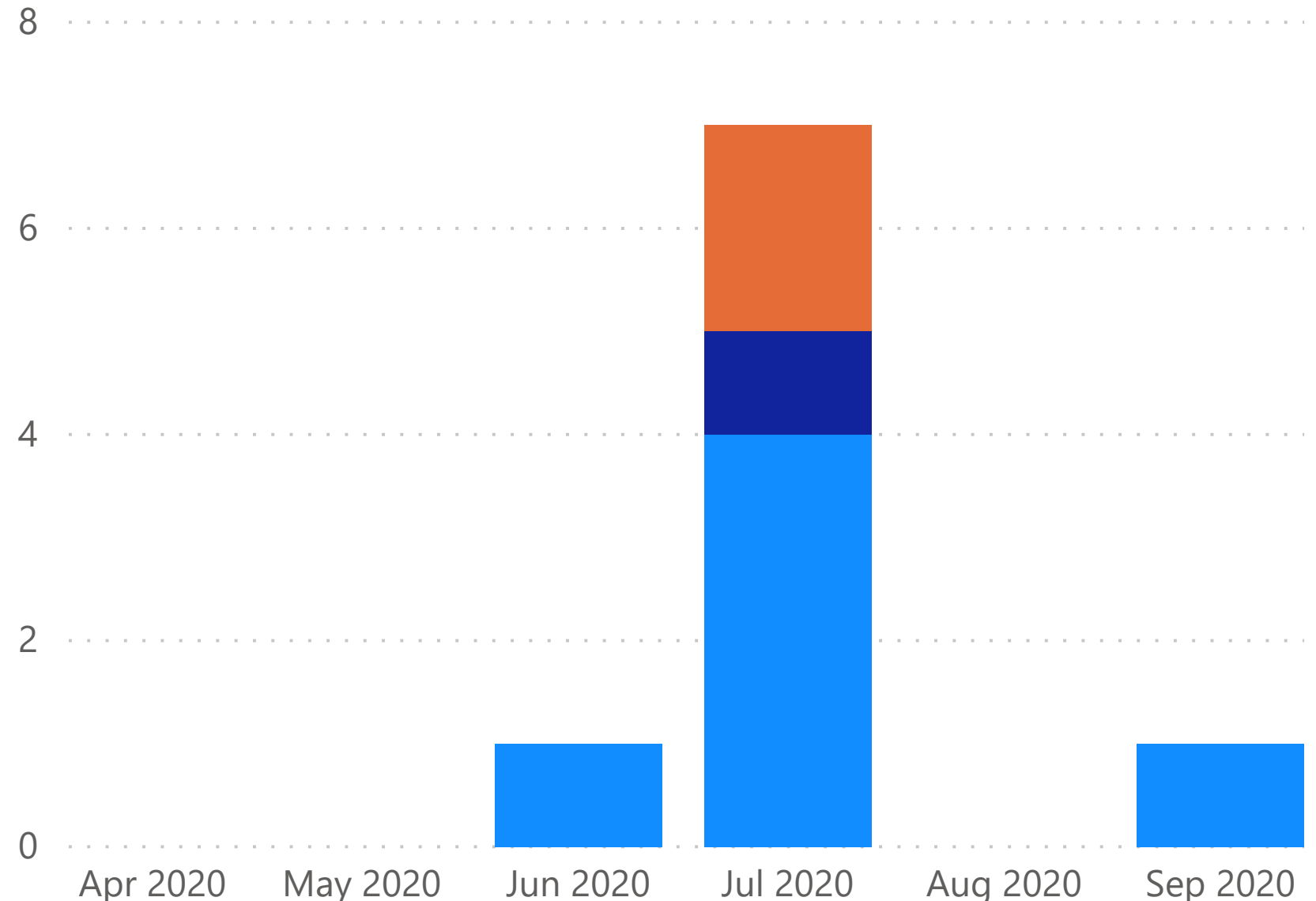

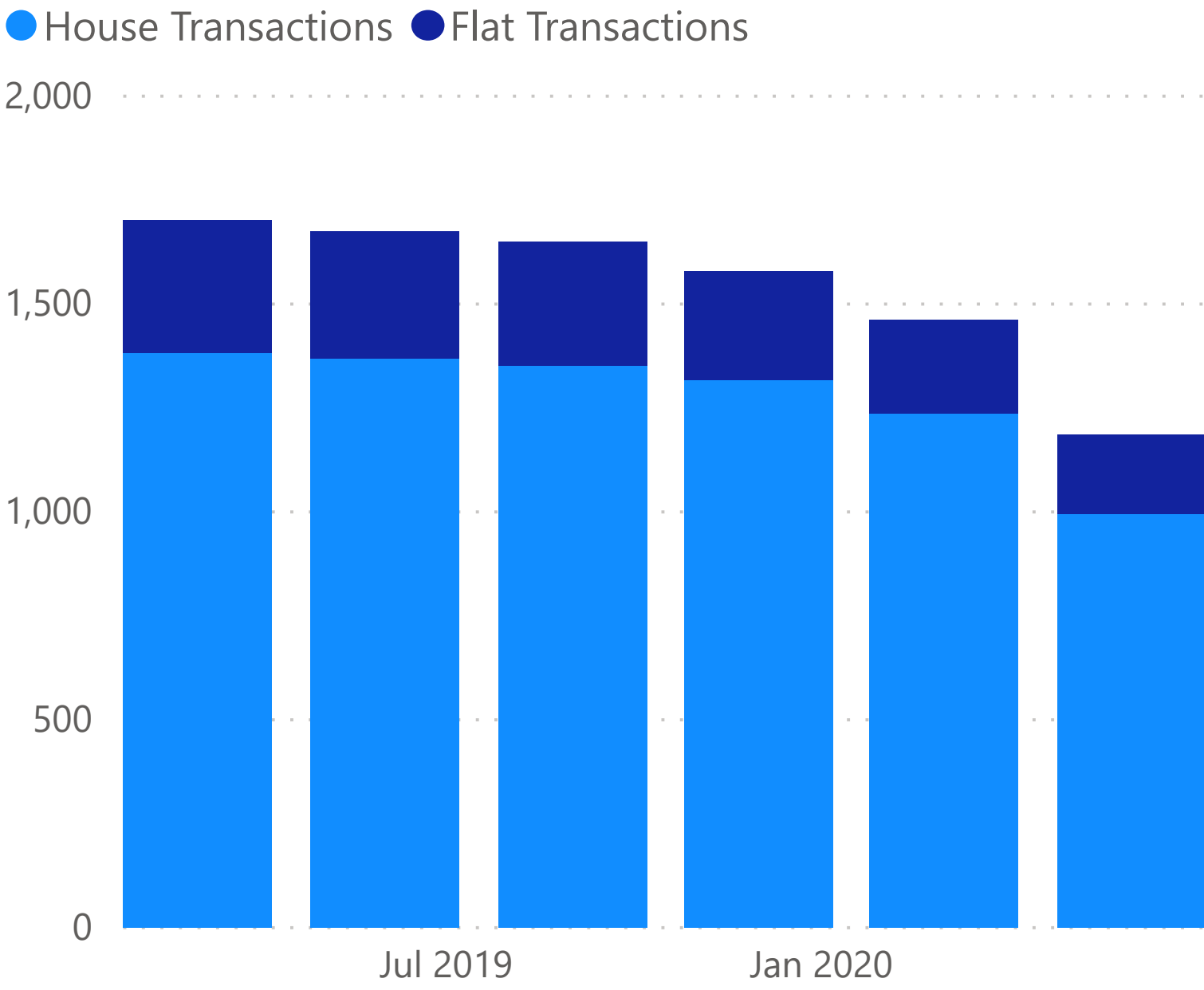

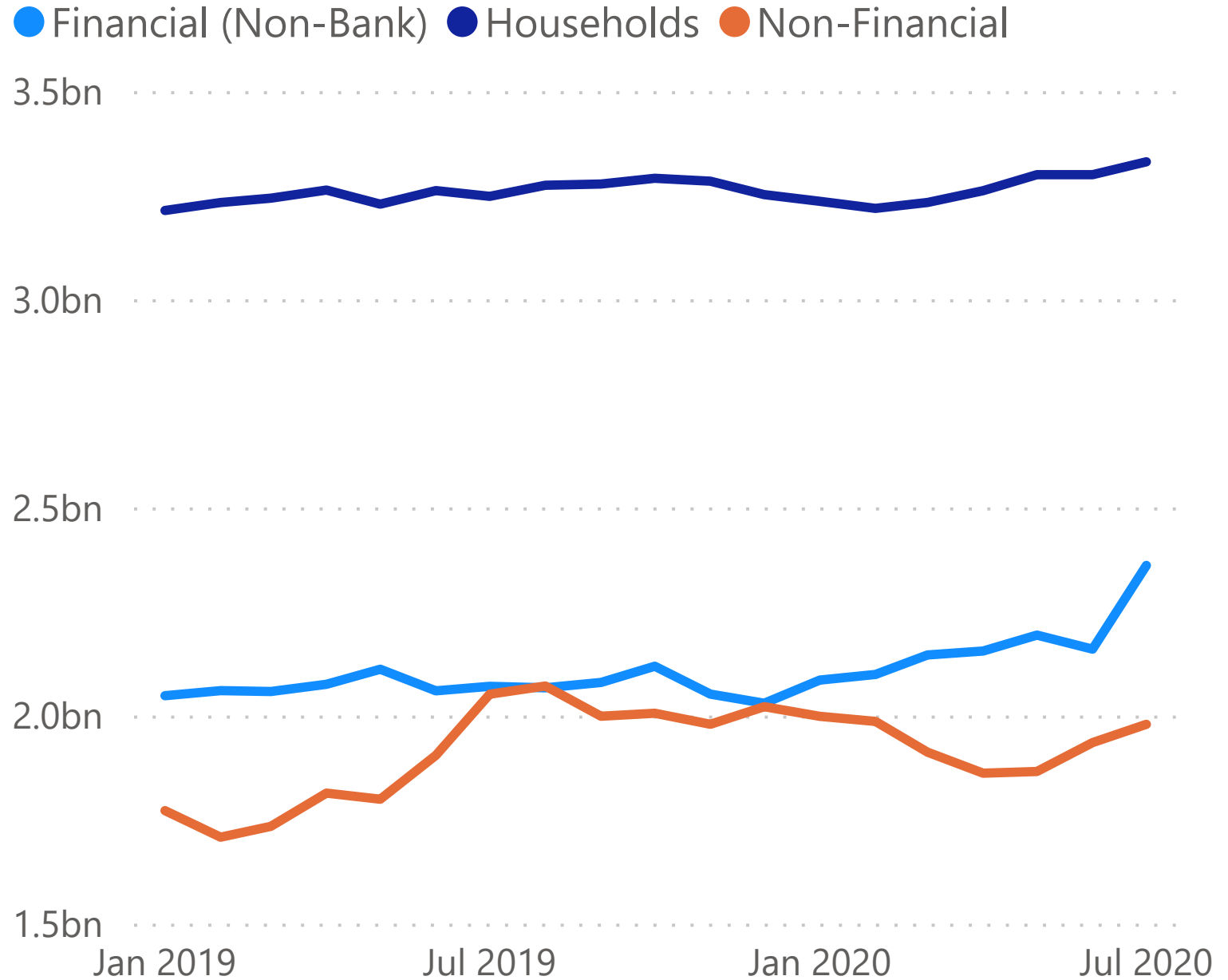

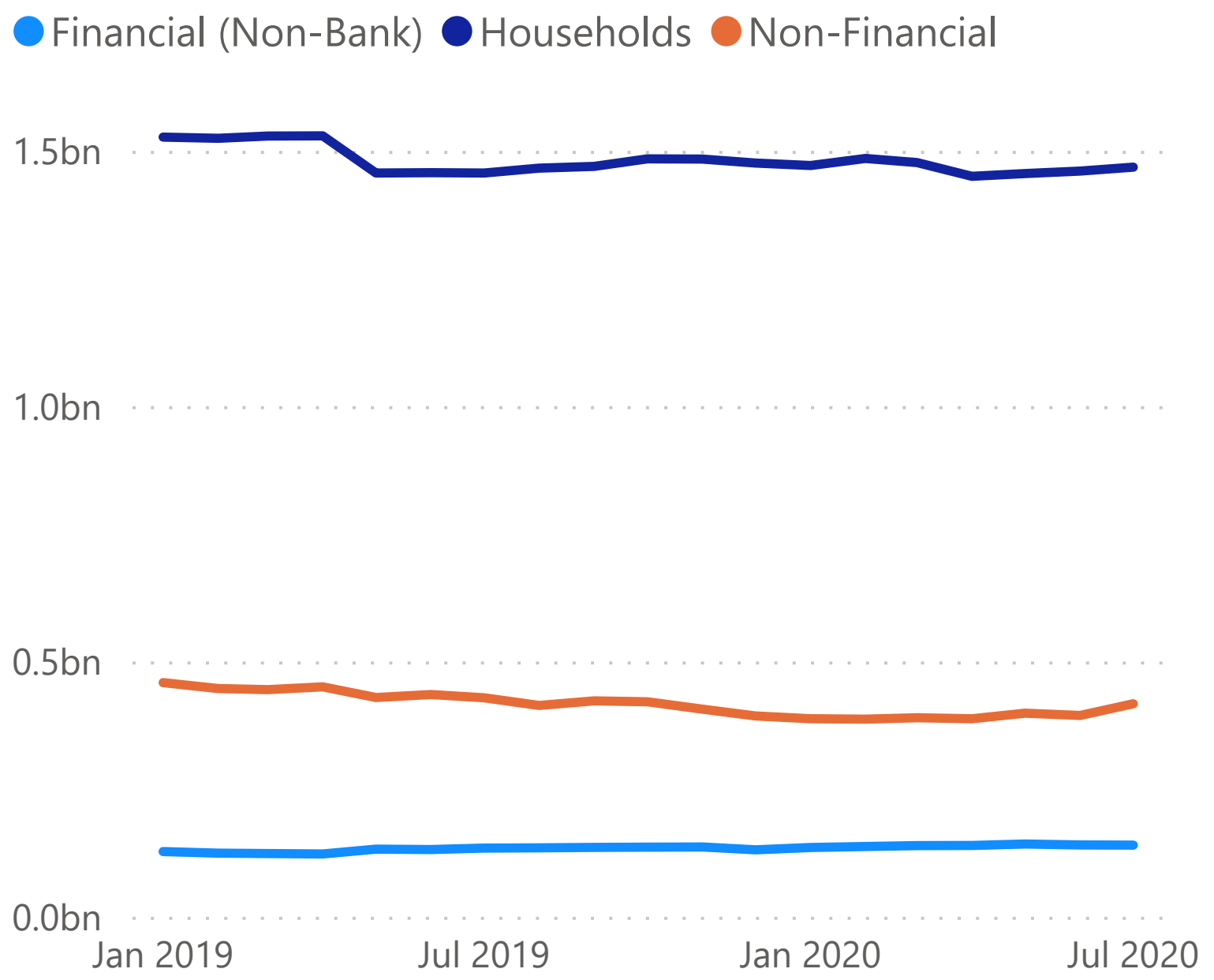

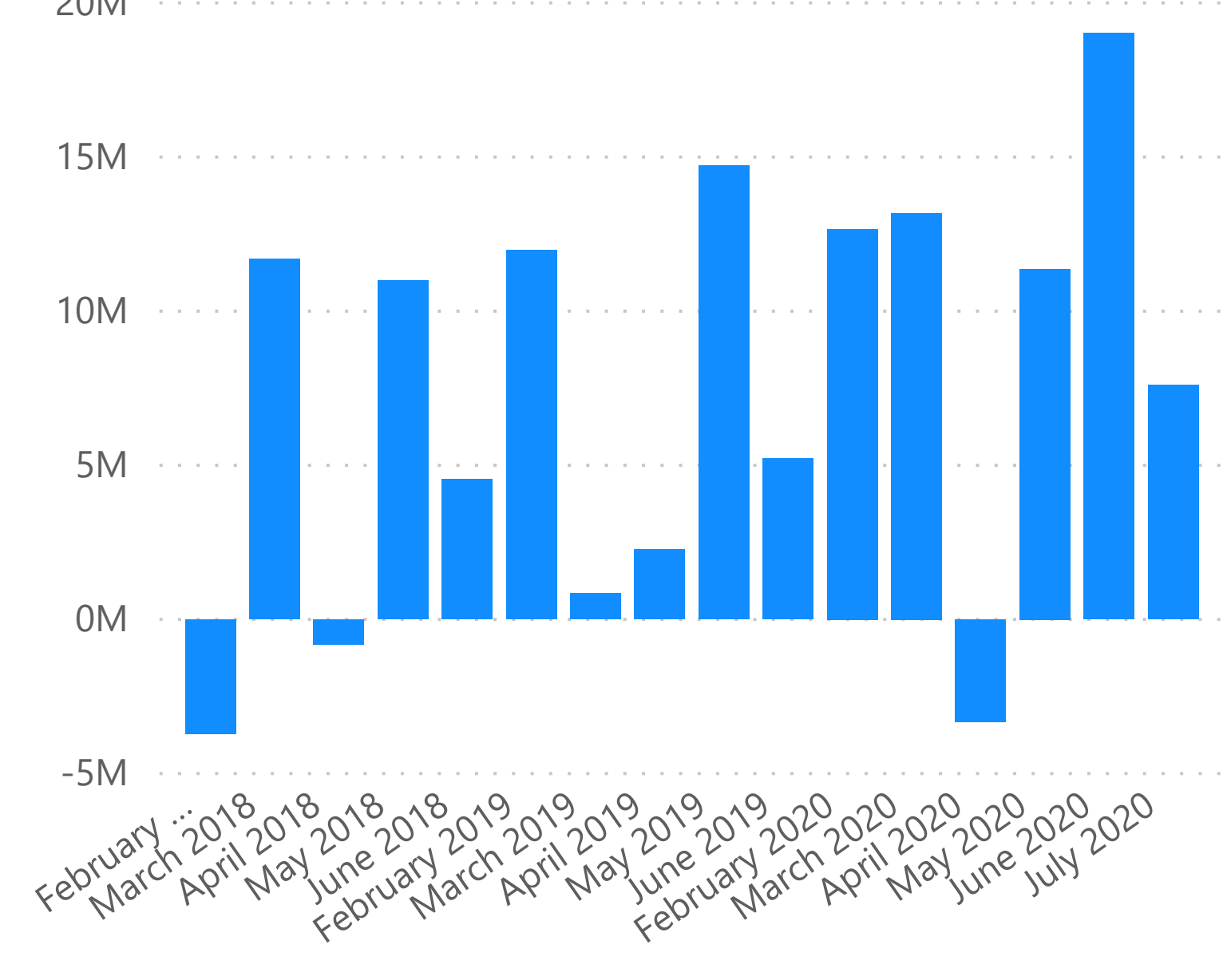

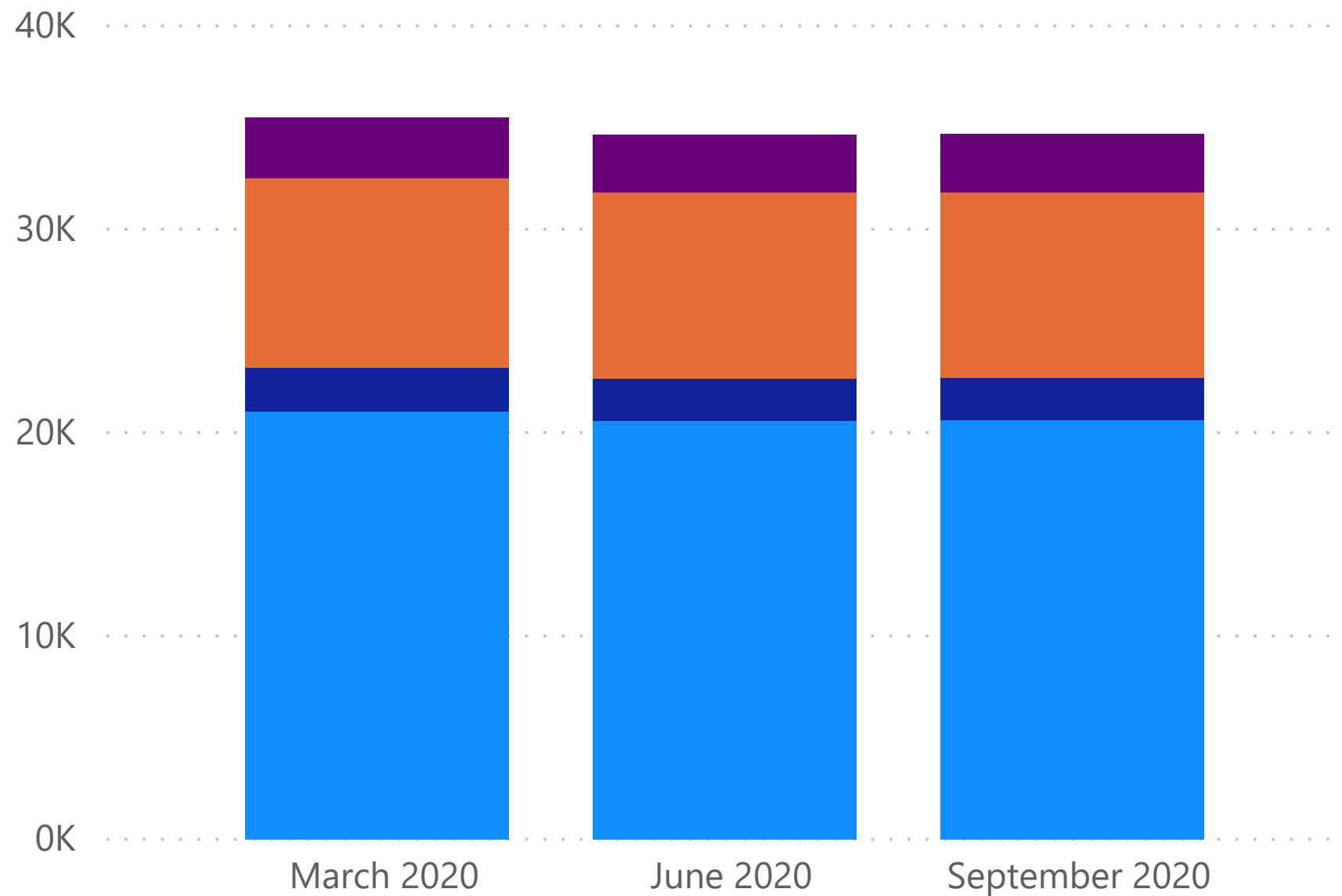

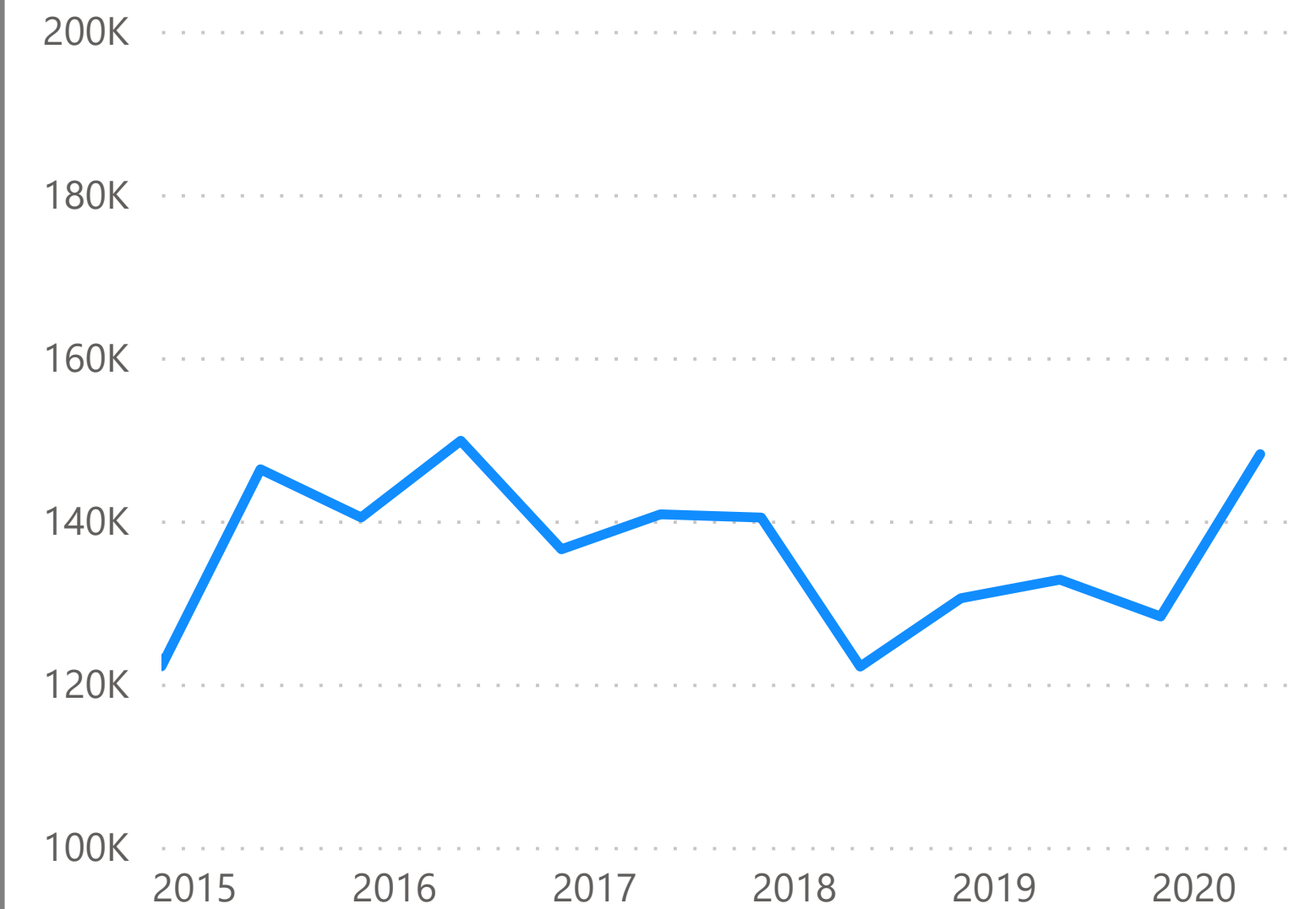

Quarry Royalties and Cement Imports are likely to represent activity levels for larger construction companies. This data may not reflect the performance of smaller companies and self-employed builders.

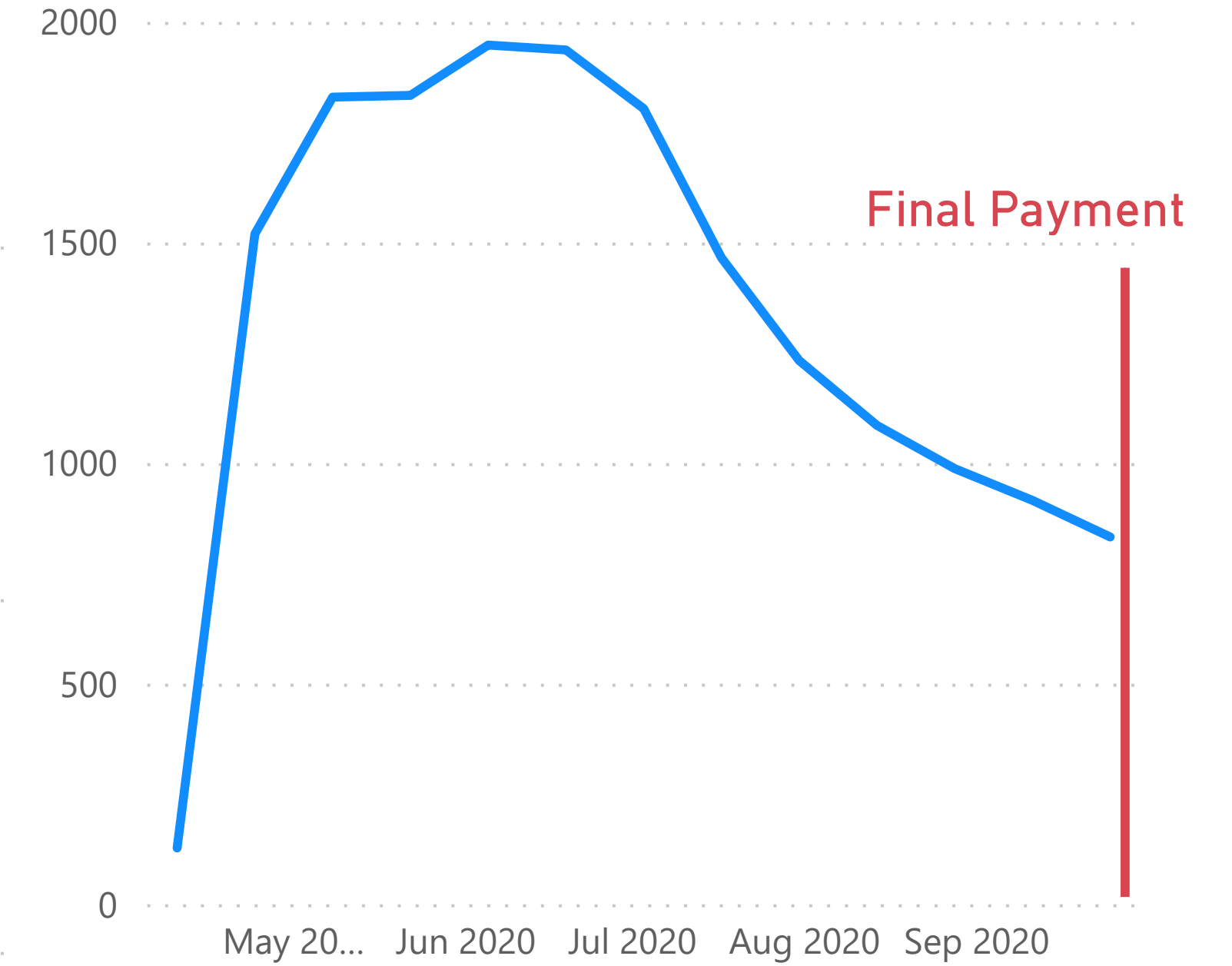

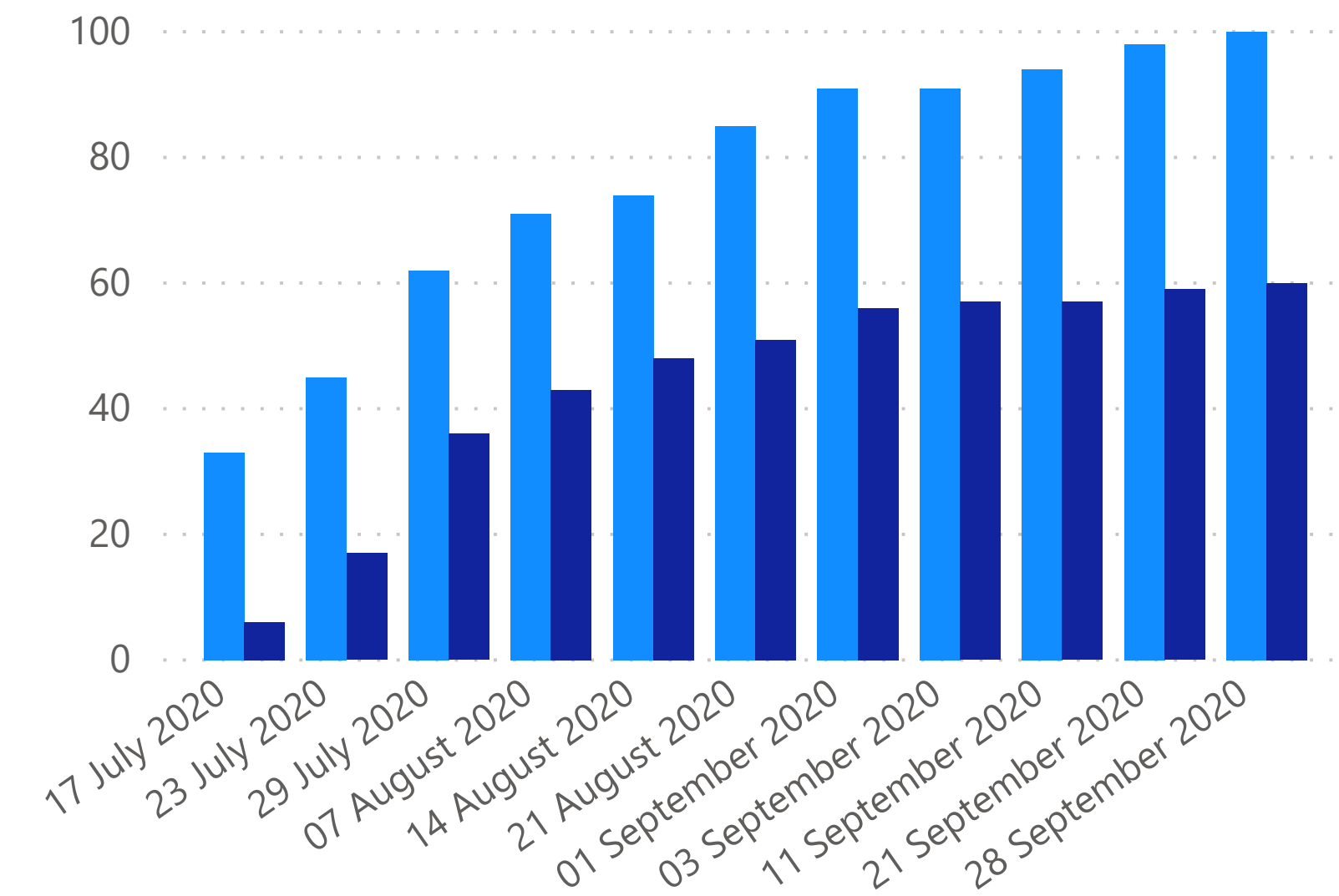
